

## **Terms of Use for Uploading Photographs to the No Touch® Best Dressed Gallery ("Terms of Use")**

You must be 18 years or older to upload a photograph ("Photograph") to the No Touch® Best Dressed Gallery at [www.bestdressednation.com](http://www.bestdressednation.com) ("Site"), which is owned and operated by Permatex, a Division of Illinois Tool Works ("ITW"). By uploading a Photograph to the Site, you hereby represent that (1) you are at least 18 years of age and that you have read these Terms of Use and Permatex's Terms of Use & Privacy Policy, that you are fully familiar with their content and agree to be bound by their provisions; (2) you agree to upload or post to the Site only Photographs that you have taken or created yourself and that you have all rights to transmit and license and that do not violate trademark, copyright, privacy or any other rights of any other person; (3) you are solely responsible for the Photograph's associated profile (including name, image, and likeness), messages, notes, text, information, and other content that is uploaded in conjunction with your Photograph.

You agree that you will not upload, post, or submit any Photograph to the Site that contains any content that: (1) depicts anyone under the age of 18 at the time the photograph was taken; (2) is offensive, vulgar, sexually explicit, racial, hateful, discriminating, unlawful, or invasive of another's privacy; (3) contains information or instructions concerning illegal activities, information that is harmful, violent, threatening, abusive, harassing, defamatory, libelous, tortuous, obscene, or otherwise objectionable; (4) harasses, threatens, abuses, defames, degrades, embarrasses or causes distress upon another; (5) you do not have a right to transmit under any law, including but not limited to a Photograph that infringes copyright, trademark, trade secret, patent or other proprietary right or violates any right of privacy or publicity; (6) contains personally identifiable information of you or anyone else, including but not limited to complete license plates numbers and full names; (7) contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer software or hardware or telecommunications equipment; (8) disrupts the normal flow of information available on or through the Site or otherwise interferes with or disrupts the functionality of the Site; (9) constitutes unsolicited advertising, promotional material, or any other form of solicitation; (10) intentionally or unintentionally violates any applicable local, state, national or international law or regulation; (11) impersonates any person or entity or otherwise misrepresents your affiliation with a person or entity; (12) links to or refers to content not allowed under these Terms of Use; or (13) otherwise uses the site's Photograph upload service in a manner deemed inappropriate by Permatex.

By uploading a photograph: (1) you grant Permatex a perpetual, irrevocable, non-exclusive worldwide, royalty-free license to use, copy, print, display, reproduce, modify, publish, publicly display, post, transmit, edit, create derivative works based upon, and distribute any Photograph you upload for editorial, commercial, promotional and all other purposes in any media; (2) you certify that you obtained, prior to submission of the Photograph, any and all releases and consents necessary to permit the use and exhibition of the Photograph by Permatex in the manner set forth in these Terms of Use, including, without limitation, name and likeness permissions from any person who appears in or is identifiable in the Photograph; and (3) you agree to indemnify Permatex, ITW, and their subsidiaries, affiliates, directors, officers, and employees

and hold them harmless from any and all claims and expenses, included attorneys' fees, arising from any Photograph you upload and/or your failure to comply with these Terms of Use.

While you retain ownership of all right, title, and interest in the Photograph itself, you agree that Permatex owns all right, title, and interest in any compilation, collective work or other derivative work created by Permatex using or incorporating any Photograph you submit to the site.

You further understand, and thereby authorize, that your Photograph may be accessed, viewed, stored or reproduced by Permatex and viewed by visitors to the Site. You waive any right to privacy in connection with your submission of the Photograph, and you waive any right to inspect or approve uses of the Photograph or to be compensated for any such uses.
